- Under the provision of Section 26 of the of the *Swimming Pool Act 1992* the applicant is entitled to appeal to the Land and Environment Court against the local authority's within twenty eight (28) days of refusal of the application.
- The local authority's failure to determine the application within six (6) weeks after it is made is taken, for the purposes of any such appeal, to be a refusal of the application.
