RE: KEMPSEY SHIRE COUNCIL'S PROPOSED ANNUAL LICENCE STRATEGY

In reference to the letter sent to all Annual Licence holders in December 2019 advising that Kempsey Shire Council (Council) is reviewing its approach to the provision of Annual Licence sites within Macleay Valley Coast Holiday Parks at Crescent Head, Hat Head, Stuarts Point and Grassy Head, Council would like to further advise that the proposed Annual Licence Site Management Strategy and 10-year holiday park concept plans will be presented to Council for consideration on **16 March 2021**.

As you may be aware, a Council resolution passed in December 2019 required that Council undertake an Economic and Social Impact Assessment for the future of Annual Licence sites within Council's Holiday Parks. Since the resolution in 2019, Council engaged an external consultant, Locale Consulting, to undertake a series of public consultation processes to better understand local community and site-user views concerning future development of the Macleay Valley Coast Holiday Parks.

Locale Consulting also consulted with Annual Licence holders to assess the social and economic impacts associated with the strategic future management of Annual Licenced sites.

As a result of the consultation process outcomes, a Business Paper has now been developed outlining the Annual Licence Site Management Strategy.

As is the process for each monthly Council meeting, this Business Paper will be published on **9 March 2021**, and Council invites you to review the Business Paper, the proposed Annual Licence Site Management Strategy and 10 year holiday park concept plans, which can be located at the following website link:
